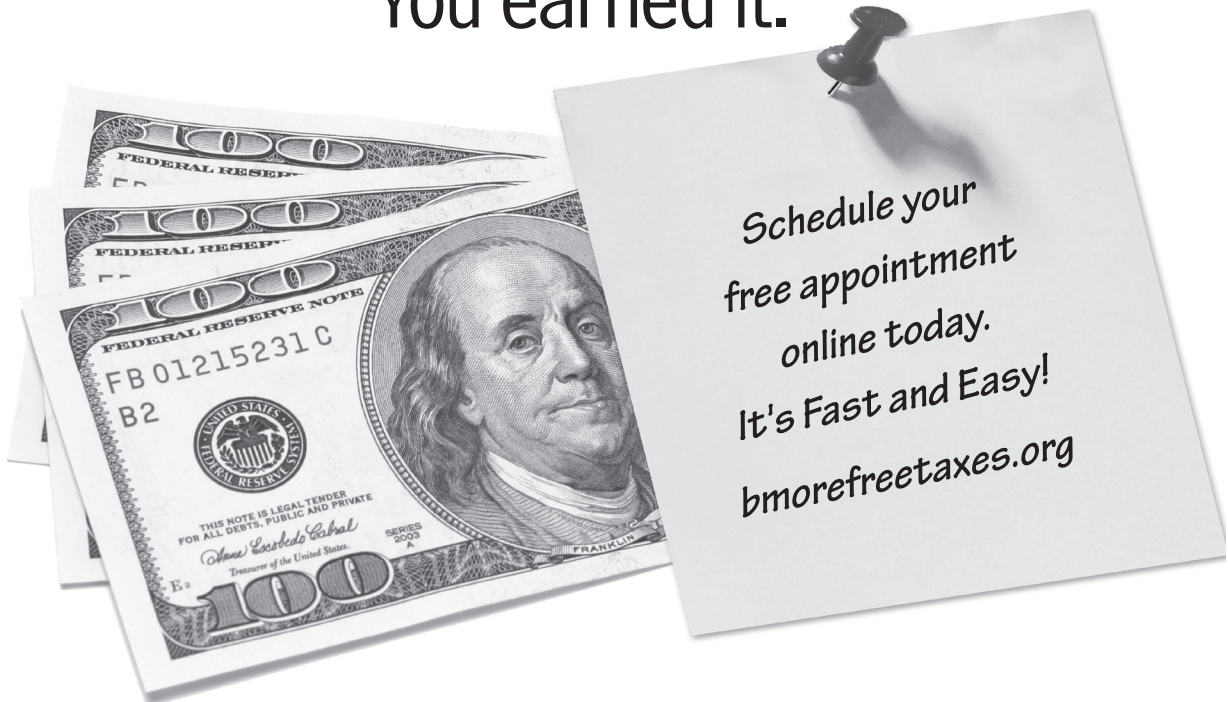

When you come to the FREE tax location, bring the following:

- ✓ A social security card for EACH family member
- ✓ W-2 forms for all jobs worked in 2011
- ✓ Child care provider name, address, and tax ID number
- ✓ All banking account information (a voided check and/or saving deposit slip) to direct deposit your refund into up to three separate accounts
- ✓ A copy of last year's tax return
- ✓ Any document or information about money you have received from the IRS or Maryland
- ✓ All 1099 forms for other income, if any
- ✓ Any other tax related documents you have received
- ✓ Every adult on your return must come to sign the return



All sites are ADA compliant unless noted.
